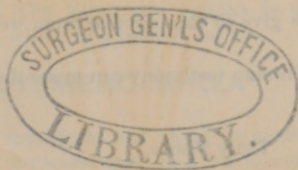

VIBURNUM OPULUS,

(The Basis of the Viburnum Compound,)

M. Sig. Thirty to sixty drops on sugar, or in mucilage, and repeat as often as required until the hemorrhage is controlled, when smaller doses should be given on extended time. Special Directions

For the administration of the Viburnum Compound in dysmenorrhœa.
