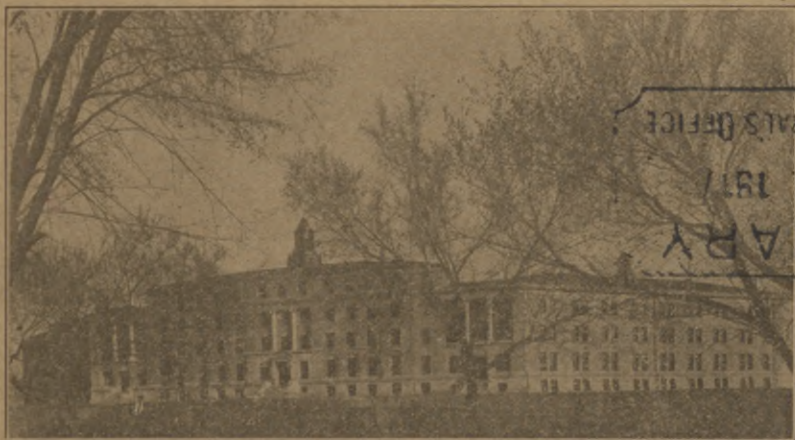

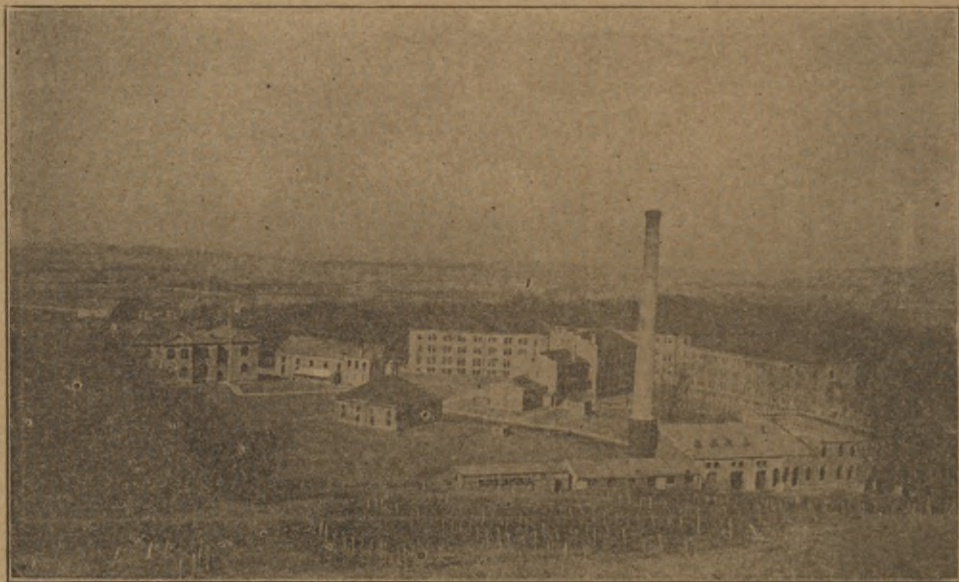

WHAT THE IOWA SCHOOL FOR THE DEAF IS.

The Iowa School for the Deaf is maintained by the State of Iowa as a free school for the education of its deaf children. It is a progressive school and all methods of benefit to its pupils used in any school for the deaf, either private or public, are recognized in this school.

Every pupil entering school of suitable age and capacity is assigned to the ORAL DEPARTMENT in which speech and lip-reading are taught. If, however, after a thorough and patient trial which may extend over several terms, it becomes apparent that the pupil can not be so instructed, and his mental development consequently retarded, he is transferred to the MANUAL DEPARTMENT. In other words for the child's good and its education we make the method fit the child; not the child, the method.

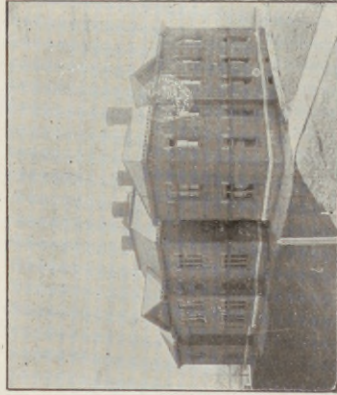
There should be no misunderstanding as to the recognition, this school extends to the methods of teaching articulation and lip-reading. It is used whenever and wherever satisfactory, beneficial and practical results can be obtained.

More than one half the scholars are instructed in the oral method, and hence parents need have no fear if their children have the necessary ability of their not being taught "how to talk."

This school recognizes no special direction of religious belief. It is absolutely non-denominational. The right of parents to suggest and desire church affiliations for their children is fully and cheerfully recognized.

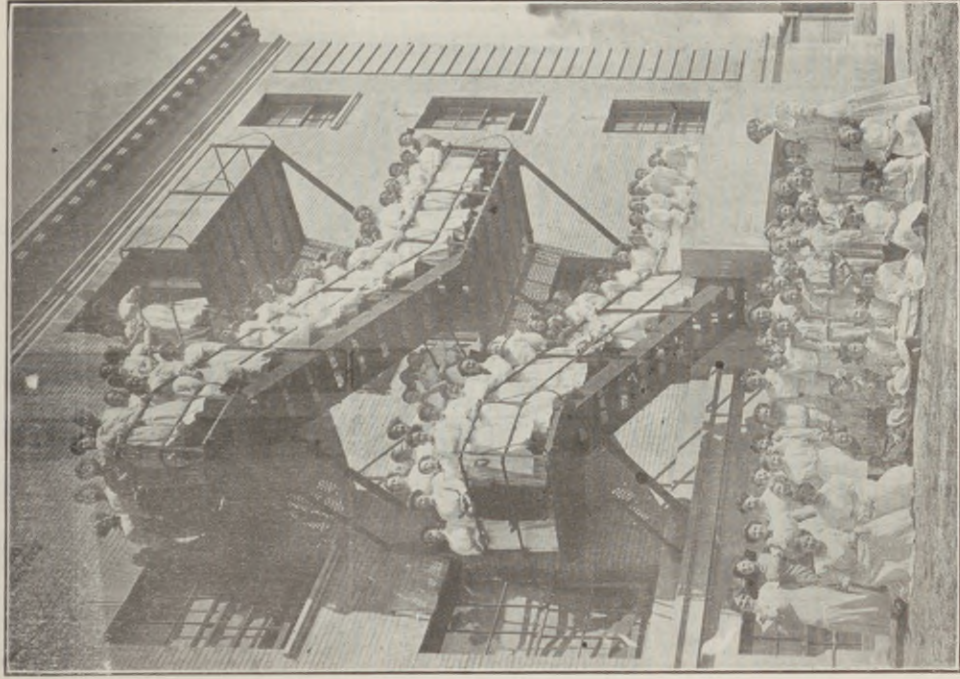

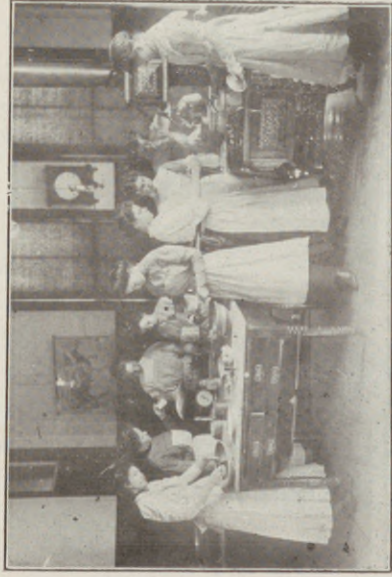

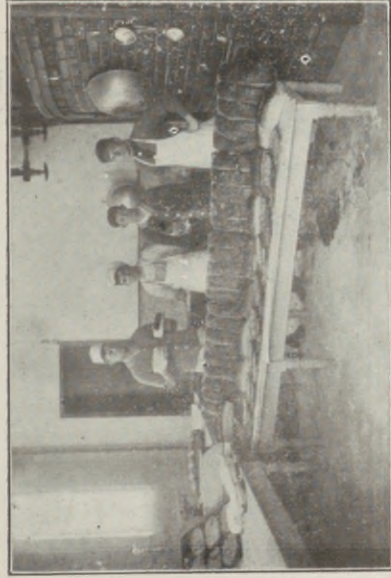

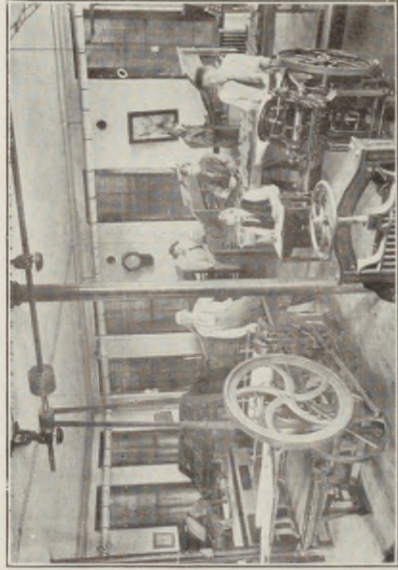

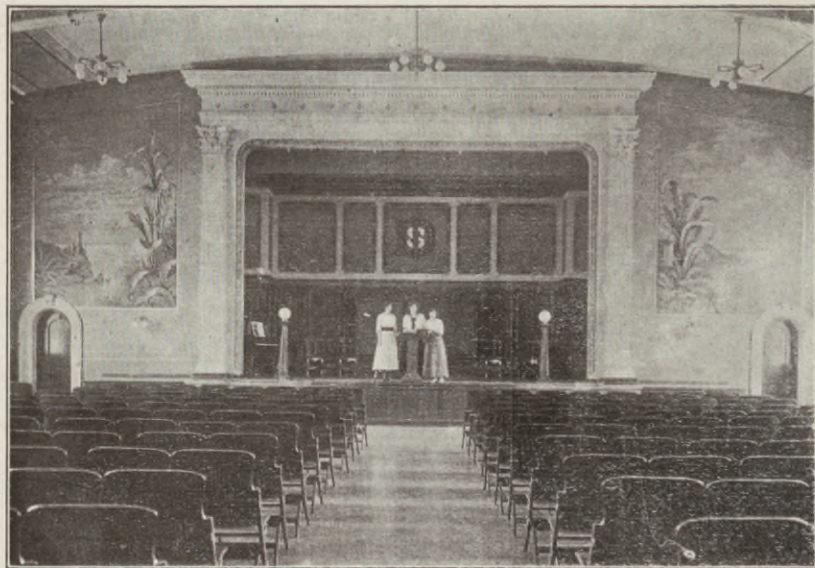

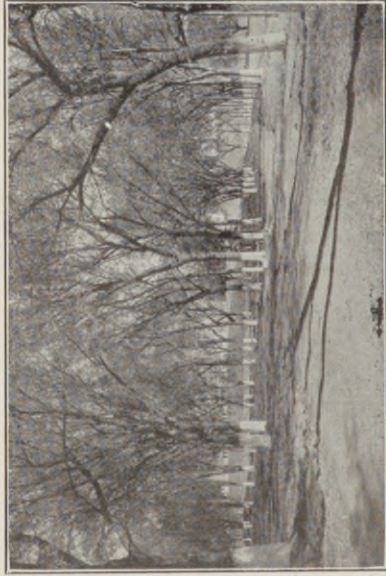

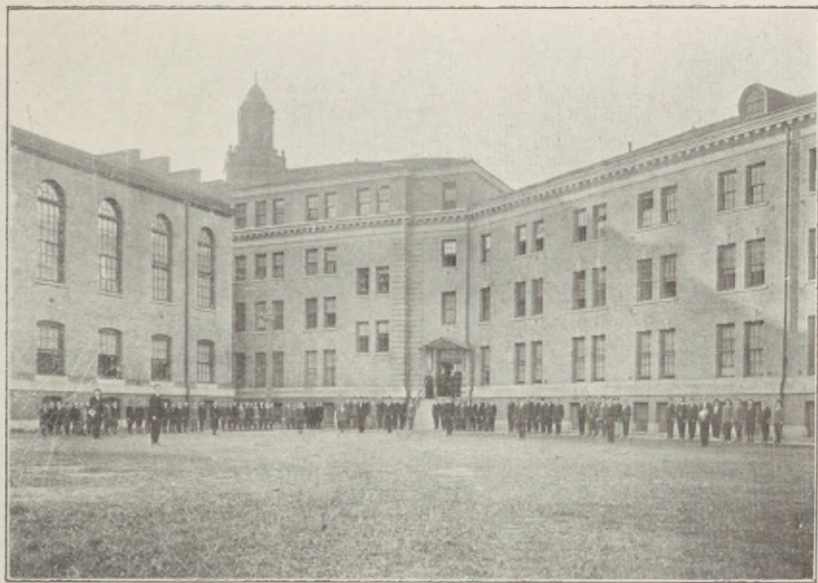

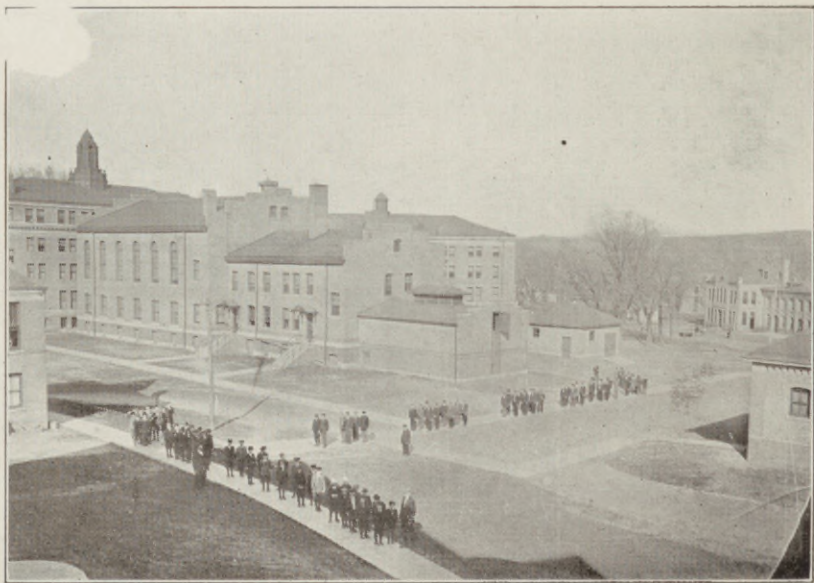

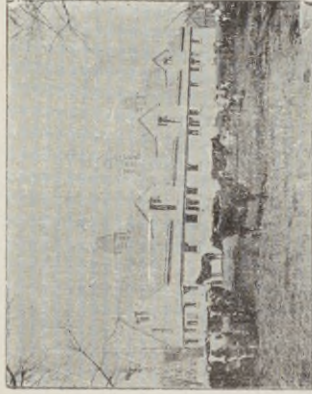

FOR GENERAL INFORMATION LAWS OF IOWA GOVERNING THE SCHOOL.

Chapter II Section 2724:

"Every resident of the State of Iowa who is not less than five nor more than twenty-five years of age who is deaf and dumb or so deaf as to be unable to acquire an education in the public schools and every such person who is over twenty-one and under thirty-five years of age, who has the consent of the Board of Control of State Institutions, shall be entitled to receive an education in the institution at the expense of the State and non-residents similarly situated may be entitled to an education therein, upon the payment of sixty-six dollars quarterly in advance."

Section 2726: "When pupils are not supplied with clothing or transportation it shall be furnished by the superintendent who shall make out an account thereof against the parent or guardian, if the pupil be a minor and against the pupil if he has no parent or guardian, or has attained the age of majority which bill shall be certified by him to be correct and shall be presumptive evidence thereof in all courts."

From the above it is apparent that the Iowa School for the Deaf is not a hospital, an asylum or a place of refuge but what its name clearly implies a SCHOOL, a part of the general public school system of the state. Admissions are free at any time to the deaf children of school age of suitable capacity. There is no charge for board, tuition or books, parents only pay transportation, furnish the necessary clothing and provide for necessary incidentals just as in the schools for the hearing. Desiring to extend the blessings of this free school to every deaf child in the State, correspondence is solicited.

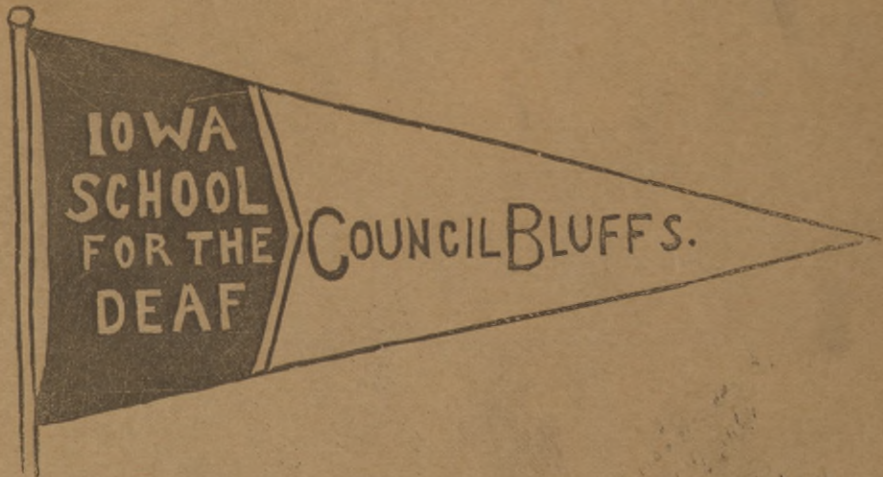
