

(4) On 7-20-59, defendants Bo Wilkerson and Ben Hutchison traveled to Chicago, Ill., and obtained unknown quantities of *amphetamine sulfate tablets*;

(5) On 7-22-59, defendant Bo Wilkerson sold to a Government agent, at Wyatt, Mo., without the required prescription, a large quantity of *amphetamine sulfate tablets* in unlabeled containers and had on hand a large supply of *amphetamine sulfate tablets* in unlabeled containers;

(6) On 8-10-59, telephone contact was made by defendant Ben Hutchison from Cairo, Ill., to defendant Vincent J. Zuckerman;

(7) On 8-18-59, defendant Bo Wilkerson dispensed to a Government agent at Wyatt, Mo., without the required prescription, a quantity of *amphetamine sulfate tablets* in unlabeled containers;

(8) On 9-23-59, defendant Bo Wilkerson dispensed to a Government agent, at Wyatt, Mo., without the required prescription, a quantity of *amphetamine sulfate tablets* in unlabeled containers;

(9) Within the period from 4-8-59 to 10-29-59, defendants A.C.D. Medical Supply, Inc., and Vincent J. Zuckerman, caused to be delivered to defendants Bo Wilkerson and Ben Hutchison unknown quantities of *amphetamine sulfate tablets* in labeled and partially labeled bottles and boxes.

The information alleged further, in two other counts, that the defendants, on 4-8-59, caused quantities of *amphetamine sulfate tablets*, which had been shipped in interstate commerce, to be dispensed without a prescription and on 8-5-59, caused quantities of *amphetamine sulfate tablets*, which were manufactured in the State of Missouri from ingredients shipped in interstate commerce, to be dispensed without a prescription.

PLEA: Guilty by all defendants.

DISPOSITION: 4-8-60. A.C.D. Medical Supply, Inc.—\$3,000 fine; Zuckerman—1 year's imprisonment.

5-6-60. Wilkerson and Hutchison were each fined \$2,000, plus costs.

INFORMATION FILED: 10-27-59, S. Dist. Ga., against Clayton Jones, Helena, Ga.

CHARGE: Between 1-12-59 and 3-10-59, *amphetamine sulfate tablets* were dispensed 4 times without a prescription.

PLEA: Guilty.

DISPOSITION: 1-18-60. \$1,000 fine and probation for 2 years.

INFORMATION FILED: 10-30-59, N. Dist. Ill., against Robert Rubin Yablon, t/a Sharon Rexall Drugs, Chicago, Ill., Paul Lawrence (a truck driver), and Pola Lawrence.

CHARGE: The information (count 1) alleged that, commencing on 7-19-59 and continuing to the date of the filing of the information, the defendants conspired and agreed with each other and with other unknown persons to commit offenses against the United States with respect to the unlawful dispensing of quantities of amphetamine drugs while held for sale after shipment in interstate commerce, thereby causing the drugs to become misbranded; and that it was a part of the conspiracy for the defendants to purchase large quantities of amphetamine drugs which had been shipped in interstate commerce, to
