

VIOLATIVE SALES OF PRESCRIPTION DRUGS

6501. (F.D.C. No. 44951. S. No. 74-026 P.)

INFORMATION FILED: 12-23-60, M. Dist. Ala., against William M. McDaniel, Jr.,
(an employee of a truck stop at Eufaula, Ala.).

CHARGE: On 9-1-59, *amphetamine sulfate tablets* were dispensed once without
a prescription.

PLEA: Guilty.

DISPOSITION: 1-24-61. Probation for 3 years.

6502. (F.D.C. No. 44950. S. Nos. 71-223 P, 16-083 R, 16-089 R.)

INFORMATION FILED: 1-4-61, S. Dist. Ohio, against William Lehrer, t/a Sunset
Truck Stop, Lewisburg, Ohio, and Marvis L. Brown (employee).

CHARGE: Between 8-12-59 and 7-14-60, *amphetamine sulfate tablets* were dis-
pensed 3 times without a prescription.

PLEA: Guilty by Lehrer to all 3 counts of the information; and by Brown to
count 1.

DISPOSITION: 2-28-61. Lehrer fined \$1,000, and given a sentence of 60 days
in jail, which sentence was suspended. Brown fined \$500.

6503. (F.D.C. No. 43667. S. Nos. 3-204/5 P, 3-208 P, 44-520/1 P, 44-534/5 P,
44-584/5 P, 44-588 P, 44-621/2 P, 44-629 P.)

INFORMATION FILED: 11-1-60, W. Dist. N.C., against Mason Allgood, t/a Big
Bertha Service Station, Charlotte, N.C., and Winston G. Bridges (employee).

CHARGE: Between 10-6-58 and 12-19-58, *amphetamine sulfate tablets* were dis-
pensed 8 times without a prescription.

PLEA: Guilty.

DISPOSITION: 4-6-61. Mason Allgood was fined a total of \$1,500 on counts 3,
4, and 5 of the information and the prayer for judgment against him on
counts 6, 7, and 8 was continued for 3 years. Winston Bridges was fined a
total of \$500 on counts 1 and 2 of the information.

6504. (F.D.C. No. 44945. S. Nos. 98-323 P, 98-328 P, 98-331 P.)

INFORMATION FILED: 12-5-60, E. Dist. Mo., against Paul H. Malone, t/a Ma-
lone's Garage, Poplar Bluff, Mo.

CHARGE: Between 1-28-60 and 2-24-60, *amphetamine sulfate tablets* were dis-
pensed 3 times without a prescription.

PLEA: Guilty.

DISPOSITION: 4-10-61. \$1,000 fine, plus costs.

6505. (F.D.C. No. 44959. S. Nos. 29-199 P, 74-022 P, 74-036 P.)

INFORMATION FILED: 2-13-61, N. Dist. Ala., against Binford L. Bell, t/a Bell's
Pure Oil Station, Scottsboro, Ala., and Howard Bell (employee).

CHARGE: Between 8-14-59 and 9-11-59, *amphetamine sulfate tablets* were dis-
pensed 3 times without a prescription.

PLEA: Guilty.

DISPOSITION: 4-17-61. Each defendant fined \$500.
