INTRODUCTION

This ready reference guide is highly selective. It is intended to help persons find information quickly using standard sources. Except when noted, the titles are basic or classic. Most of the titles are located in the general Reading Room, as indicated by "Ref" over the call number. The few entries that do not have this designation are in the general collection stacks and may be requested through the Reader Service Desk.

It must be emphasized that scholars, historical researchers, and others who need more than a ready reference collection should consult the History of Medicine Division and plan to use its collections. For information about the collection and services of the History of Medicine Division, telephone 496-5405 between 8:30 A.M. and 4:45 P.M., Monday through Friday.

The National Library of Medicine's resources for historical scholarship in the medical and related sciences are among the richest in the world. These are housed and maintained by the History of Medicine Division. They include all of the Library's material printed before 1871 plus thousands of later pamphlets and dissertations, totaling close to 500,000 pieces. The Division's collections also include modern manuscripts, numbering nearly 1,000,000 items and some oral history memoirs. An extensive collection of prints and photographs, containing some 75,000 items, are also housed in the History of Medicine Division.

The general Reading Room offers a rich collection of biographical reference tools both general and specific, current and retrospective. The following highly selected titles are specific for medicine and also science and technology. XI. COMPUTER DATABASES

NLM makes available various computer databases related to biomedicine and health. Numerous libraries and other sites through the United States and the world provide access to the databases. NLM's Reference Section generally provides searching only for those individuals within the Library's immediate geographic vicinity who do not have access to the system through their organization or school. The following files contain items of interest in the history of medicine.

CATLINE

Includes all monographs cataloged by NLM since 1801 and some earlier imprints. Pre-1801 titles not cited in CATLINE might be located in the History of Medicine Division. Also includes serial titles. The printed version of CATLINE since 1966 is the NATIONAL LIBRARY OF MEDICINE CURRENT CATALOG. MEDICAL SUBJECT HEADINGS (MeSH) and textwords are used for searching. Updated weekly. Library users may search CATLINE themselves on terminals available in the catalog area.

HISTLINE

Online database of literature published for the most part since 1970, with a few citations since 1964. References in HISTLINE are to monographs, journal articles, meetings, and miscellaneous publications from the annually printed BIBLIOGRAPHY OF THE HISTORY OF MEDICINE. International in coverage, "The scope includes the history of medicine and related sciences, professions, individuals, institutions, drugs and diseases of given chronological periods and geographical areas." The sources of the titles in HISTLINE are INDEX MEDICUS, CURRENT CATALOG, history of medicine and science journals, and current publications from various fields such as general history and classics. MeSH, certain special terms, and textwords are used to search the database. Updated monthly.

MEDLINE

Includes current journal articles on the history of medicine. Of 2,695 journals indexed, fourteen are scanned either cover-to-cover or selectively for historical articles. The printed counterpart of MEDLINE is monthly INDEX MEDICUS and the annual CUMULATED INDEX MEDICUS. The MEDLINE holdings for the history of medicine are also included in HISTLINE. MeSH and textwords are used for searching. Updated monthly.
