AREA V LIBRARY SERVICES COMMITTEE

The Library Services Committee is now approximately half-way through a survey of the needs of Area V for library services. This is being accomplished by holding meetings in each of the eight "districts" of Area V to bring together hospital administrators, librarians, chairmen of library committees, in-service nursing directors, directors of medical education in hospitals, representatives from the Public Health Dept. and County Medical Association Districts, public library systems, nursing school libraries, college libraries, pharmaceutical company libraries and social service agencies.

At each meeting, the current thinking of the committee about proposed improvements in library services is communicated to those present; an attempt is made to assess existing resources; and the perceived needs of health professionals regarding library resources is solicited.

The need most frequently mentioned at each of the meetings, states Dr. John S. Lloyd, (Area V staff) is that of training for non-professional library attendants at hospitals in each community. Another frequently expressed thought is that library attendants should have at their disposal a "directory" of local availability of information for all the health professionals. There is a demand for ready access to audio-visual materials as well as printed matter and there has been discussion of the feasibility of pooling hospital libraries to build a core collection for each district.

Chairman John Connor and Dr. Lloyd agree that there is a surprising degree of enthusiasm on the part of those who attend the meetings for improvement in library services. They also report an unexpected and unplanned reaction: When existing services of the four major health sciences libraries in the county have been described, their availability has come as a pleasant surprise to some of those attending the meetings, and LACMA Library and LAC-USC Medical Center Library note increases in demand from some of the districts which the librarians feel might be ascribed to the transfer of information about the accessibility of their services at the meetings.

RMP STATEWIDE COMMITTEES

Staff Consultants

Paul Ward announced that there will be an opportunity to submit proposals prior to establishment of the once-a-year schedule. Submissions for the April review must be received by Feb. 1, 1971. Decisions regarding continuation or modifications to projects completing their 3rd year must also be made at the April meeting of CCRMP.

Regional Stroke Committee

Staff Consultants adopted the following resolution prepared by the Stroke Committee: "Be it resolved that the State Stroke Categorical Committee express to CCRMP Staff Consultants the importance of meeting the needs of the stroke patients on national, state and local levels. Basic to this is the creation of an awareness and interest in the establishment of programs by which the condition of the stroke patient will be improved and in the institution of techniques through which he will be protected. Further, it requests that CCRMP staff notify the two Heart Associations in the state of its concern and offer them its support in carrying out the recommendations of the newly constituted Council on Cerebral Vascular Diseases of the American Heart Association."

Regional Related Diseases Committee

Representatives of the Areas have decided to hold a Nephrology Conference December 12, 13 and 14, at a site still to be decided. Attendance of 100-150 is anticipated.

Regional Allied Health Committee

Concern with cutbacks in post-hospital care prompted the committee to prepare for distribution a statement which might be applied to legislation, to standards for insurance policies, or to any program paying benefits for medical care: "In connection with all legislation having to do with delivery of health services, which would include health insurance measures, experiments in the method of delivery and new delivery of services, and other such related measures consistent with HEW and other priorities, we urge that all such services be set up on a comprehensive basis to ensure continuity of care and rehabilitation. Included in such services prescribed by physicians are: P.T., O.T., speech therapy; home health services by licensed agency; outpatient laboratory; outpatient X-ray; health education and supervision of such as diabetics, arthritics, colostomy patients; vocational counseling where modification or job change is indicated; family counseling and mental hygiene counseling; drugs - outpatient; transportation to treatment center where not available; dietary counseling; rehabilitative equipment including hospital bed, commode, crutches, etc.; oxygen and tank." (Approved in principle by Staff Consultants at August meeting).

Allied Health Committee has approved the definition of allied health as "all medical personnel except doctors, dentists, and pharmacists."
