THIS IS TO ADVISE YOU OF THE DECISIONS RESULTING FROM REVIEW OF THE PHASE-OUT PLANS SUBMITTED ON MARCH 15 BY THE NASSAU/SUFFOLK REGIONAL MEDICAL PROGRAM. THE DECISIONS ARE AS FOLLOWS:

1. THE TERMINATION DATE FOR THE NASSAU/SUFFOLK REGIONAL MEDICAL PROGRAM IS JULY 31, 1973. THIS IS THE DATE BEYOND WHICH NO RMP'S GRANT FUNDS MAY BE EXPENDED.
2. THE APPROVED DIRECT COST LEVEL IS NOW \$802,666, PLUS APPROPRIATE INDIRECT COSTS. AN AMENDED AWARD WILL BE ISSUED FOR THE NEW APPROVED BUDGET PERIOD SEPTEMBER 1, 1972 THROUGH JULY 31, 1973.
