## AN ACT

Making appropriations for the Departments of Labor, and Health, Education, and Welfare, and related agencies, for the fiscal year ending June 30, 1962, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*  
3       That the following sums are appropriated, out of any money  
4       in the Treasury not otherwise appropriated, for the Depart-  
5       ments of Labor, and Health, Education, and Welfare, and  
6       related agencies, for the fiscal year ending June 30, 1962,  
7       namely:

## 1 TITLE I—DEPARTMENT OF LABOR

## 2 OFFICE OF THE SECRETARY

## 3 SALARIES AND EXPENSES

4 For expenses necessary for the Office of the Secretary  
5 of Labor (hereafter in this title referred to as the Secretary),  
6 purchase of one passenger motor vehicle for replacement  
7 only at not to exceed \$5,000, ~~(1)\$1,711,000~~ \$1,811,000, of  
8 which not more than \$2,000 shall be for official entertain-  
9 ment expenses.

## 10 BUREAU OF LABOR-MANAGEMENT REPORTS

## 11 SALARIES AND EXPENSES

12 For expenses necessary for the Bureau of Labor-  
13 Management Reports, \$5,775,000.

## 14 BUREAU OF INTERNATIONAL LABOR AFFAIRS

## 15 SALARIES AND EXPENSES

16 For expenses necessary for the conduct of international  
17 labor affairs, ~~(2)\$444,000~~ \$510,000.

## 18 OFFICE OF THE SOLICITOR

## 19 SALARIES AND EXPENSES

20 For expenses necessary for the Office of the Solicitor,  
21 ~~(3)\$3,616,000~~ \$4,116,000.

## 22 BUREAU OF LABOR STANDARDS

## 23 SALARIES AND EXPENSES

24 For expenses necessary for the promotion of industrial  
25 safety, employment stabilization, and amicable industrial

1 relations for labor and industry; performance of safety func-  
2 tions of the Secretary under the Federal Employees' Com-  
3 pensation Act, as amended (5 U.S.C. 784 (c)) and the  
4 Longshoremen's and Harbor Workers' Compensation Act, as  
5 amended (72 Stat. 835); performance of the functions  
6 vested in the Secretary by sections 8 (b) and (c) of the  
7 Welfare and Pension Plans Disclosure Act (72 Stat. 997);  
8 and not less than \$276,000 for the work of the Presi-  
9 dent's Committee on Employment of the Physically Handi-  
10 capped, as authorized by the Act of July 11, 1949 (63  
11 Stat. 409); ~~(4)\$3,208,000~~ \$3,258,000: *Provided*, That no  
12 part of the appropriation for the President's Committee shall  
13 be subject to reduction or transfer to any other department  
14 or agency under the provisions of any existing law; including  
15 purchase of reports and of material for informational exhibits.

#### 16 BUREAU OF VETERANS' REEMPLOYMENT RIGHTS

##### 17 SALARIES AND EXPENSES

18 For expenses necessary to render assistance in connec-  
19 tion with the exercise of reemployment rights under section  
20 8 of the Selective Training and Service Act of 1940, as  
21 amended (50 U.S.C. App. 308), the Service Extension  
22 Act of 1941, as amended (50 U.S.C. App. 351), the Army  
23 Reserve and Retired Personnel Service Law of 1940, as  
24 amended (50 U.S.C. App. 401), and section 9 of the Uni-  
25 versal Military Training and Service Act (50 U.S.C. App.

1 459), and the Reserve Forces Act of 1955 (69 Stat. 598),  
 2 \$633,000.

3 BUREAU OF APPRENTICESHIP AND TRAINING  
 4 SALARIES AND EXPENSES

5 For expenses necessary to enable the Secretary to con-  
 6 duct a program of encouraging apprentice training, as author-  
 7 ized by the Acts of March 4, 1913 (5 U.S.C. 611), and  
 8 August 16, 1937 (29 U.S.C. 50), \$4,976,000.

9 BUREAU OF EMPLOYMENT SECURITY  
 10 LIMITATION ON SALARIES AND EXPENSES

11 For expenses necessary for the general administration  
 12 of the employment service and unemployment compensation  
 13 programs, including temporary employment of persons, with-  
 14 out regard to the civil-service laws, for the farm placement  
 15 migratory labor program; not more than ~~(5)\$9,600,000~~  
 16 \$10,500,000 may be expended from the employment security  
 17 administration account in the Unemployment trust fund, of  
 18 which \$1,369,000 shall be for carrying into effect the provi-  
 19 sions of title IV (except section 602) of the Servicemen's  
 20 Readjustment Act of 1944.

21 LIMITATION ON GRANTS TO STATES FOR UNEMPLOYMENT  
 22 COMPENSATION AND EMPLOYMENT SERVICE ADMINIS-  
 23 TRATION

24 For grants in accordance with the provisions of the Act  
 25 of June 6, 1933, as amended (29 U.S.C. 49-49n), for



1 carrying into effect section 602 of the Servicemen's Re-  
2 adjustment Act of 1944, for grants to the States as author-  
3 ized in title III of the Social Security Act, as amended (42  
4 U.S.C. 501-503), including, upon the request of any State,  
5 the purchase of equipment, and the payment of rental for  
6 space made available to such State in lieu of grants for such  
7 purpose, for necessary expenses including purchasing and  
8 installing of air-conditioning equipment in connection with  
9 the operation of employment office facilities and services in  
10 the District of Columbia, and for the acquisition of a building  
11 through such arrangements as may be required to provide  
12 quarters for such offices and facilities in the District of  
13 Columbia and for the District of Columbia Unemployment  
14 Compensation Board, including conveyance by the Com-  
15 missioners of the District of Columbia to the United States  
16 of title to the land on which such building is to be situated,  
17 subject to the same conditions with respect to the use of  
18 these funds for such purposes as are applicable to the pro-  
19 curement of buildings for other State employment security  
20 agencies, and for expenses not otherwise provided for, neces-  
21 sary for carrying out title XV of the Social Security Act, as  
22 amended (68 Stat. 1130), not more than ~~(6)~~\$391,700,000  
23 \$406,700,000 may be expended from the employment se-  
24 curity administration account in the Unemployment trust  
25 fund, of which \$15,000,000 shall be available only to the

1 extent necessary to meet increased costs of administration  
2 resulting from changes in a State law or increases in the  
3 numbers of claims filed and claims paid or increased salary  
4 costs resulting from changes in State salary compensation  
5 plans embracing employees of the State generally over those  
6 upon which the State's basic grant (or the allocation for  
7 the District of Columbia) was based, which increased costs  
8 of administration cannot be provided for by normal budget-  
9 tary adjustments: *Provided*, That notwithstanding any pro-  
10 vision to the contrary in section 302 (a) of the Social Se-  
11 curity Act, as amended, the Secretary of Labor shall from  
12 time to time certify to the Secretary of the Treasury for  
13 payment to each State found to be in compliance with the  
14 requirements of the Act of June 6, 1933, and, except in  
15 the case of Guam and the Virgin Islands, with the provi-  
16 sions of section 303 of the Social Security Act, as amended,  
17 such amounts as he determines to be necessary for the  
18 proper and efficient administration of its unemployment  
19 compensation law and of its public employment offices:  
20 *Provided further*, That such amounts as may be agreed  
21 upon by the Department of Labor and the Post Office  
22 Department shall be used for the payment, in such manner  
23 as said parties may jointly determine, of postage for the  
24 transmission of official mail matter in connection with the

1 administration of unemployment compensation systems and  
2 employment services by States receiving grants herefrom.

3 In carrying out the provisions of said Act of June 6,  
4 1933, the provisions of section 303 (a) (1) of the Social  
5 Security Act, as amended, relating to the establishment and  
6 maintenance of personnel standards on the merit basis, shall  
7 apply.

8 None of the funds appropriated by this title to the  
9 Bureau of Employment Security for grants-in-aid of State  
10 agencies to cover, in whole or in part, the cost of operation  
11 of said agencies, including the salaries and expenses of offi-  
12 cers and employees of said agencies, shall be withheld from  
13 the said agencies of any States which have established by  
14 legislative enactment and have in operation a merit system  
15 and classification and compensation plan covering the selec-  
16 tion, tenure in office, and compensation of their employees,  
17 because of any disapproval of their personnel or the manner  
18 of their selection by the agencies of the said States, or the  
19 rates of pay of said officers or employees.

20 Grants to States, next succeeding fiscal year: For mak-  
21 ing, after May 31 of the current fiscal year, payments to  
22 States under title III of the Social Security Act, as amended,  
23 and under the Act of June 6, 1933, as amended, for the first  
24 quarter of the next succeeding fiscal year, such sums as may

1 be necessary, the obligations incurred and the expenditures  
 2 made thereunder for payments under such title and under  
 3 such Act of June 6, 1933, to be charged to the appropria-  
 4 tion therefor for that fiscal year: *Provided*, That the pay-  
 5 ments made pursuant to this paragraph shall not exceed  
 6 the amount paid to the States for the first quarter of the  
 7 current fiscal year.

8 (7) *PAYMENT TO THE FEDERAL EXTENDED COMPENSATION*

9 *ACCOUNT*

10 *For payment into the Federal extended compensation*  
 11 *account of the unemployment trust fund, as repayable*  
 12 *advances, as authorized by section 13 of the Temporary*  
 13 *Extended Unemployment Compensation Act of 1961, \$390,-*  
 14 *000,000, to remain available only until September 30, 1962.*

15 *ADVANCES TO EMPLOYMENT SECURITY ADMINISTRATION*

16 *ACCOUNT, UNEMPLOYMENT TRUST FUND*

17 *For an additional amount for capital for the Revolving*  
 18 *fund, \$20,000,000.*

19 *UNEMPLOYMENT COMPENSATION FOR FEDERAL*

20 *EMPLOYEES AND EX-SERVICEMEN*

21 *For payments to unemployed Federal employees and*  
 22 *ex-servicemen, either directly or through payments to States,*  
 23 *as authorized by title XV of the Social Security Act, as*  
 24 *amended, \$147,000,000.*

1 Unemployment compensation for Federal employees and  
 2 ex-servicemen, next succeeding fiscal year: For making,  
 3 after May 31 of the current fiscal year, payments to States,  
 4 as authorized by title XV of the Social Security Act, as  
 5 amended, such amounts as may be required for payment to  
 6 unemployed Federal employees and ex-servicemen for the  
 7 first quarter of the next succeeding fiscal year, and the obliga-  
 8 tions and expenditures thereunder shall be charged to the  
 9 appropriation therefor for that fiscal year: *Provided*, That  
 10 the payments made pursuant to this paragraph shall not  
 11 exceed the amount paid to the States for the first quarter of  
 12 the current fiscal year.

13 COMPLIANCE ACTIVITIES, MEXICAN FARM LABOR PROGRAM

14 For expenses necessary to enable the Department to  
 15 determine compliance with the provisions of contracts  
 16 entered into pursuant to the Act of July 12, 1951, as  
 17 amended, \$720,000.

18 SALARIES AND EXPENSES, MEXICAN FARM LABOR

19 PROGRAM

20 For expenses, not otherwise provided for, necessary to  
 21 carry out the functions of the Department of Labor under  
 22 the Act of July 12, 1951, as amended (7 U.S.C. 1461-  
 23 1468), including temporary employment of persons without

1 regard to the civil-service laws, \$925,000, which shall be  
2 derived by transfer from the Farm labor supply revolving  
3 fund.

4 BUREAU OF EMPLOYEES' COMPENSATION

5 SALARIES AND EXPENSES

6 For necessary administrative expenses and not to ex-  
7 ceed \$103,225 for the Employees' Compensation Appeals  
8 Board, \$3,834,000, together with not to exceed \$55,000 to  
9 be derived from the fund created by section 44 of the Long-  
10 shoremen's and Harbor Workers' Compensation Act, as  
11 amended (33 U.S.C. 944).

12 EMPLOYEES' COMPENSATION CLAIMS AND EXPENSES

13 For the payment of compensation and other benefits and  
14 expenses (except administrative expenses) authorized by  
15 law and accruing during the current or any prior fiscal year,  
16 including payments to other Federal agencies for medical and  
17 hospital services pursuant to agreement approved by the  
18 Bureau of Employees' Compensation; continuation of pay-  
19 ment of benefits as provided for under the head "Civilian  
20 War Benefits" in the Federal Security Agency Appropria-  
21 tion Act, 1947; the advancement of costs for enforcement  
22 of recoveries in third-party cases; the furnishing of medical  
23 and hospital services and supplies, treatment, and funeral  
24 and burial expenses, including transportation and other  
25 expenses incidental to such services, treatment, and burial,

1 for such enrollees of the Civilian Conservation Corps as were  
 2 certified by the Director of such Corps as receiving hospital  
 3 services and treatment at Government expense on June 30,  
 4 1943, and who are not otherwise entitled thereto as civilian  
 5 employees of the United States, and the limitations and  
 6 authority of the Act of September 7, 1916, as amended (5  
 7 U.S.C. 796), shall apply in providing such services, treat-  
 8 ment, and expenses in such cases and for payments pursuant  
 9 to sections 4 (c) and 5 (f) of the War Claims Act of 1948  
 10 (50 U.S.C. App. 2012) ; \$64,000,000: *Provided*, That, in  
 11 the adjudication of claims under section 42 of the said Act  
 12 of 1916, for benefits payable from this appropriation, au-  
 13 thority under section 32 of the Act to make rules and regu-  
 14 lations shall be construed to include the nature and extent of  
 15 the proofs and evidence required to establish the right to such  
 16 benefits without regard to the date of the injury or death  
 17 for which claim is made.

18 BUREAU OF LABOR STATISTICS

19 SALARIES AND EXPENSES

20 For expenses, not otherwise provided for, necessary for  
 21 the work of the Bureau of Labor Statistics, including ad-  
 22 vances or reimbursement to State, Federal, and local agen-  
 23 cies and their employees for services rendered, ~~(8)\$12,167,~~  
 24 ~~000~~ \$12,667,000.

## 1 REVISION OF THE CONSUMER PRICE INDEX

2 For expenses necessary to enable the Bureau of Labor  
3 Statistics to revise the Consumer Price Index, ~~(9)~~including  
4 not to exceed \$50,000 for temporary employees at rates to  
5 be fixed by the Secretary of Labor ~~(but not to exceed a rate~~  
6 ~~equivalent to the lowest rate for general schedule grade 9)~~  
7 ~~without regard to the civil service laws and Classification Act~~  
8 ~~of 1949, as amended, \$2,100,000~~(10), *to remain available*  
9 *until June 30, 1963.*

## 10 WOMEN'S BUREAU

## 11 SALARIES AND EXPENSES

12 For expenses necessary for the work of the Women's  
13 Bureau, as authorized by the Act of June 5, 1920 (29  
14 U.S.C. 11-16), including purchase of reports and material  
15 for informational exhibits, \$668,000.

## 16 WAGE AND HOUR DIVISION

## 17 SALARIES AND EXPENSES

18 For expenses necessary for performing the duties im-  
19 posed by the Fair Labor Standards Act of 1938, as amended,  
20 and the Act to provide conditions for the purchase of supplies  
21 and the making of contracts by the United States, approved  
22 June 30, 1936, as amended (41 U.S.C. 35-45), including  
23 reimbursement to State, Federal, and local agencies and their  
24 employees for inspection services rendered, ~~(11)~~\$12,261,000  
25 \$17,761,000.



1 This title may be cited as the "Department of Labor  
2 Appropriation Act, 1962".

3 TITLE II—DEPARTMENT OF HEALTH, EDUCA-  
4 TION, AND WELFARE

5 FOOD AND DRUG ADMINISTRATION

6 SALARIES AND EXPENSES

7 For necessary expenses not otherwise provided for, of  
8 the Food and Drug Administration, including reporting and  
9 illustrating the results of investigations; purchase of chem-  
10 icals, apparatus, and scientific equipment; payment in  
11 advance for special tests and analyses by contract; and pay-  
12 ment of fees, travel, and per diem in connection with  
13 studies of new developments pertinent to food and drug  
14 enforcement operations; (12)~~\$23,580,000~~ \$22,000,000.

15 SALARIES AND EXPENSES, CERTIFICATION, INSPECTION,  
16 AND OTHER SERVICES

17 For expenses necessary for the listing, certification or  
18 inspection of certain products, and for the establishment of  
19 tolerances for pesticides and color additives, in accordance  
20 with sections 406, 408, 504, 506, 507, 604, 702A, and  
21 706 of the Federal Food, Drug, and Cosmetic Act, as  
22 amended (21 U.S.C. 346, 346a, 354, 356, 357, 364, 372a,  
23 and 376), the aggregate of the advance deposits during  
24 the current fiscal year to cover payments of fees for serv-  
25 ices in connection with such certifications, inspections, or

1 establishment of tolerances, to remain available until ex-  
 2 pended. The total amount herein appropriated shall be  
 3 available for purchase of chemicals, apparatus, and scien-  
 4 tific equipment; expenses of advisory committees; and the  
 5 refund of advance deposits for which no service has been  
 6 rendered.

7 PHARMACOLOGICAL-ANIMAL LABORATORY BUILDING

8 For plans, specifications, and construction of a special  
 9 pharmacological-animal laboratory for the Food and Drug  
 10 Administration, \$1,750,000, to remain available until  
 11 expended.

12 FREEDMEN'S HOSPITAL

13 SALARIES AND EXPENSES

14 For expenses necessary for operation and maintenance,  
 15 including repairs; furnishing, repairing, and cleaning of wear-  
 16 ing apparel used by employees in the performance of their  
 17 official duties; transfer of funds to the appropriation "Salaries  
 18 and expenses, Howard University" for salaries of technical  
 19 and professional personnel detailed to the hospital; payments  
 20 to the appropriation of Howard University for actual cost  
 21 of heat, light, and power furnished by such university;  
 22 \$3,736,000: *Provided*, That no intern or resident physician  
 23 receiving compensation from this appropriation on a full-time  
 24 basis shall receive compensation in the form of wages or  
 25 salary from any other appropriation in this title: *Provided*

1 *further*, That the District of Columbia shall pay by check to  
2 Freedmen's Hospital, upon the Surgeon General's request,  
3 in advance at the beginning of each quarter, such amount as  
4 the Surgeon General calculates will be earned on the basis of  
5 rates approved by the Bureau of the Budget for the care of  
6 patients certified by the District of Columbia. Bills ren-  
7 dered by the Surgeon General on the basis of such calcula-  
8 tions shall not be subject to audit or certification in advance  
9 of payment; but proper adjustment of amounts which have  
10 been paid in advance on the basis of such calculations shall  
11 be made at the end of each quarter: *Provided further*, That  
12 the Surgeon General may delegate the responsibilities im-  
13 posed upon him by the foregoing proviso.

14 OFFICE OF EDUCATION  
15 PROMOTION AND FURTHER DEVELOPMENT OF VOCATIONAL  
16 EDUCATION

17 For carrying out the provisions of section 3 of the Vo-  
18 cational Education Act of 1946, as amended (20 U.S.C.  
19 15j), and section 202 of said Act (20 U.S.C. 15bb), sec-  
20 tion 1 of the Act of March 3, 1931 (20 U.S.C. 30), the  
21 Act of March 18, 1950 (20 U.S.C. 31-33), and section 9 of  
22 the Act of August 1, 1956 (20 U.S.C. 34), including  
23 \$4,000,000 for extension and improvement of practical nurse  
24 training under title II of the Vocational Education Act of  
25 1946, as amended, which sum shall be available under such

1 title also for the expansion and improvement of programs of  
2 practical nurse training in effect prior to August 2, 1956, and  
3 \$180,000 for vocational education in the fishery trades and  
4 industry including distributive occupations therein, \$33,-  
5 672,000: *Provided*, That the amount of allotment which  
6 States and Territories are not prepared to use may be re-  
7 apportioned among other States and Territories applying  
8 therefor for use in the programs for which the funds were  
9 originally apportioned.

10 FURTHER ENDOWMENT OF COLLEGES OF AGRICULTURE AND  
11 THE MECHANIC ARTS

12 For carrying out the provisions of section 22 of the  
13 Act of June 29, 1935, as amended (7 U.S.C. 329),  
14 \$8,194,000.

15 (13) LAND-GRANT COLLEGE AID

16 *For an additional payment to the State of Hawaii, as*  
17 *authorized by section 14(e) of the Hawaii Omnibus Act*  
18 *(Public Law 86-624, approved July 12, 1960),*  
19 *\$3,775,000.*

20 GRANTS FOR LIBRARY SERVICES

21 For grants to the States, pursuant to the Act of June  
22 19, 1956, as amended (20 U.S.C. 351-358), \$7,500,000.

23 PAYMENTS TO SCHOOL DISTRICTS

24 For payments to local educational agencies for the main-  
25 tenance and operation of schools as authorized by the Act

1 of September 30, 1950, as amended (20 U.S.C., ch. 13),  
 2 \$85,700,000: *Provided*, That this appropriation shall also  
 3 be available for carrying out the provisions of section 6 of  
 4 such Act.

5 ASSISTANCE FOR SCHOOL CONSTRUCTION

6 For an additional amount for providing school facilities  
 7 and for grants to local educational agencies in federally  
 8 affected areas, as authorized by the Act of September 23,  
 9 1950, as amended (20 U.S.C., ch. 19), including not to ex-  
 10 ceed \$810,000 for necessary expenses during the current  
 11 fiscal year of technical services rendered by other agencies,  
 12 \$24,850,000, to remain available until expended: *Provided*,  
 13 That no part of this appropriation shall be available for sala-  
 14 ries or other direct expenses of the Department of Health  
 15 Education, and Welfare.

16 DEFENSE EDUCATIONAL ACTIVITIES

17 For grants, loans, and payments under the National  
 18 Defense Education Act of 1958 (72 Stat. 1580-1605),  
 19 ~~(14)~~ \$210,857,000 \$211,707,000, of which \$75,145,000  
 20 shall be for capital contributions to student loan funds and  
 21 loans for non-Federal capital contributions to student loan  
 22 funds, of which not to exceed \$1,300,000 shall be for such  
 23 loans for non-Federal capital contributions; \$54,000,000  
 24 shall be for grants to States and loans to nonprofit private

1 schools for science, mathematics, or modern foreign language  
2 equipment and minor remodeling of facilities; \$3,750,000  
3 shall be for grants to States for supervisory and other serv-  
4 ices; \$12,800,000 shall be for grants to States for area voca-  
5 tional education programs; and \$15,000,000 shall be for  
6 grants to States for testing, guidance, and counseling: *Pro-*  
7 *vided*, That no part of this appropriation shall be available for  
8 the purchase of science, mathematics, and modern language  
9 teaching equipment, or equipment suitable for use for teach-  
10 ing in such fields of education, which can be identified as  
11 originating in or having been exported from a Communist  
12 country, unless such equipment is unavailable from any other  
13 source (15): *Provided further*, That no part of this appro-  
14 priation shall be available for graduate fellowships awarded  
15 initially under the provisions of the Act after the date of enact-  
16 ment of the Department of Health, Education, and Welfare  
17 Appropriation Act, 1962, which are not found by the Com-  
18 missioner of Education to be consistent with the purpose of the  
19 Act as stated in section 101 thereof.

20 Loans and payments under the National Defense Educa-  
21 tion Act, next succeeding fiscal year: For making, after  
22 May 31 of the current fiscal year, loans and payments under  
23 title II of the National Defense Education Act, for the first  
24 quarter of the next succeeding fiscal year such sums as may  
25 be necessary, the obligations incurred and the expenditures

1 made thereunder to be charged to the appropriation for the  
 2 same purpose for that fiscal year: *Provided*, That the pay-  
 3 ments made pursuant to this paragraph shall not exceed the  
 4 amount paid for the same purpose ~~(16)~~ *during for* the first  
 5 quarter of the current fiscal year.

6           EXPANSION OF TEACHING IN EDUCATION OF THE  
 7   MENTALLY RETARDED

8           For grants to public or other nonprofit institutions of  
 9 higher learning and to State educational agencies, pursuant  
 10 to the Act of September 6, 1958, as amended (20 U.S.C.  
 11 611-617), \$1,000,000.

12   SALARIES AND EXPENSES

13           For expenses necessary for the Office of Education, in-  
 14 cluding surveys, studies, investigations, and reports regard-  
 15 ing libraries; coordination of library service on the national  
 16 level with other forms of adult education; development of  
 17 library service throughout the country; purchase, distribu-  
 18 tion, and exchange of educational documents, motion-picture  
 19 films, and lantern slides; ~~(17)~~ \$11,364,000 \$11,864,000
